Pacific Trail Pipeline Pre-Construction Work Update

2016 ACTIVITY

The tentative activities planned include:

- Proposed pipeline route right-of-way monitoring and erosion mitigation
- Road maintenance
- Potential environmental studies and surveys

2015 ACTIVITY

Chevron completed the summer 2015 work season on the proposed Pacific Trail Pipeline. It included:

- Pre-construction work on the proposed natural gas pipeline route that begins approximately 30 km south of Houston, B.C., extending 54 km to the west. This work included environmental field studies, archeological field studies, access road maintenance, upgrades and construction, surveying and clearing of the proposed right-of-way.

Measures were in place to protect culturally and environmentally sensitive areas:

- Biologists and First Nations monitors identified and flagged environmental features and sensitive areas along the right of way and access roads prior to clearing activities.
- Environmentally sensitive areas were avoided and environmental management plans were in place to minimize the impact of construction activities on the area.
- Archaeological impact assessments were conducted on the right-of-way, multi-use sites and access roads.
- A walk-through of the pipeline route took place to verify that the proposed route of the Pacific Trail Pipeline is still the safest and most environmentally sound route possible. Selection of the best watercourse crossing locations was also validated.

PROJECT OVERVIEW

The proposed Kitimat LNG project is a 50:50 co-venture between Chevron Canada Limited (Chevron) and Woodside Energy International Limited (Woodside). Chevron is the operator of the project, which includes:

- The development of natural gas resources in the Liard and Horn River Basins in northeastern B.C.
- Transportation of that natural gas across northern B.C. through a third-party pipeline and the proposed 480 km Pacific Trail Pipeline (PTP) to Kitimat. PTP is the only proposed natural gas pipeline for a LNG facility to have the full support of all 16 First Nations bands along its proposed route.
- A gas liquefaction facility at Bish Cove near Kitimat that will cool the natural gas into a liquid for shipping to overseas LNG markets.

Kitimat LNG will bring benefits to British Columbians including new jobs, business opportunities and revenue to the provincial government. Significant investment has been already been made through the early construction activities for the proposed Kitimat LNG facility site, PTP, and development of the natural gas resources in the Liard and Horn River basins.

CURRENT PROJECT STATUS:

- All major federal and provincial environmental assessment certificates are in place.
- The project is currently in the engineering and design phase to establish certainty around the project design, execution, cost and schedule.
- Substantial pre-construction site preparation work on the LNG plant and pipeline has been completed.
- First Nations benefits agreements are in place for the LNG plant and Pacific Trail Pipeline.
